## FIREWORKS PERMIT

Wisconsin statute 167.10 (3) (a) prohibits the use or possession of fireworks without a user's permit issued by the mayor of a city, president of a village or chairperson of a town in which the possession or use is to occur or from a person designated by the mayor, president or chairperson to issue a user's permit. Permits can only be issued to one of the following under (3) (c): 1) A public authority; 2) A fair association; 3) An amusement park; 4) A park board; 5) A civic organization; 6) A group of resident or nonresident individuals; 7) An agricultural producer for the protection of crops from predatory birds or animals. NOTE: Permits cannot be issued to a minor; they must be 18 years of age, under 167.10 (3) (h). A copy of this permit shall be on file with the clerk of the city, village or town.

***The undersigned authorized person by their signature understands that any violation of this permit or the regulations set by state statute can result in the confiscation of fireworks and the issuing of citations that include a forfeiture not to exceed \$1,000. Further, should the use of fireworks of any kind start a fire, the responsible party will be liable for the fire suppression costs and my be issued citations.***
